**Vacancy for the Post of Painter**

**Local Government Service**

Applications are invited from serving Tradesman's Assistants of the Local Government Service who wish to be considered for appointment as Painter in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs 13010 x 260 – 14050 x 275 – 15150 x 300 – 15750 x 325 – 17700 x 375 – 19575 x 475 – 21950 x 625 – 23200 x 775 – 23975 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 13,010 a month.

**2. Qualifications :**

*By selection from among Tradesman's Assistants in the Local Government Service who possess the Trade Test in painting or hold a certificate in painting from a recognized institution acceptable to the Local Government Service Commission.*

***Note 1: Candidates should show proof of all experience claimed.***

**Note 2: Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications and where applicable, relevant documentary evidence of all experience claimed.**

**3. Duties :**

1. To carry out the necessary measurements and calculations of the trade.
2. To use and keep in good condition the tools in general use in the trade.
3. To remove all paint with soda solution, wash and burn off paint.
4. To prepare surfaces for painting.
5. To make a putty.

6. To sand paper, paint (brush), stop up, flat down with pumice and varnish (brush) and apply putty, paints and varnishes.
7. To do ordinary distemping including preparation of walls if required.
8. To do simple glazing.
9. Must be able to prepare, mix and match paints and to use linseed oil, boiled and raw.
10. To ensure good safety conditions while on duty.
11. Other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.

#### 4. **Mode of Application**

Qualified candidates should submit their applications :

on LGSC Form 7 which may be obtained either from the office of the Local Government Service Commission, Louis Pasteur Street, Forest Side or from any Local Authority.

- (iii) Candidates should submit their applications in duplicate, the original should

be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer, who will forward it to the Commission within a week after the closing date.

- (iv) Candidates are advised to read carefully the 'NOTES AND INSTRUCTIONS TO CANDIDATES' before filling in the application form.
