

Local Government Service Commission Circular Note No. 25 of 2017

Vacancy for the post of Waste Water Pipe Cleaner
Municipal City Council of Port Louis

Applications are invited from among serving employees of the Municipal City Council of Port Louis who wish to be considered for appointment as Waste Water Pipe Cleaner in that Council.

The permanent and pensionable post carries salary in the scale of Rs 12750 x 260 – 14050 x 275 – 15150 x 300 – 15750 x 325 – 17700 x 375 – 19575 x 475 – 21950 a month plus salary compensation at approved rates.

Appointment in the grade in a temporary capacity carries salary at the flat rate of Rs 12750 a month plus salary compensation at approved rates.

2. Qualifications:

By selection from employees of the manual grade on the permanent and pensionable establishment of the Municipal City Council of Port Louis

Note 1: The onus for the submission of equivalence of qualifications (if applicable) from the relevant authorities rests on the candidates.

Note 2: Candidates should enclose photocopies of their National Identity Card, academic/technical qualifications and, where applicable, relevant documentary evidence of experience claimed.

3. Duties

1. The disblocking, scraping internal and external, cleaning and flushing of all discharge and other pipes, drains, covered gutters, inlets and outlets, premises, sites, buildings, water closets and other conveniences.
2. To collect, carry, convey and transport cleaning implements, tools and relevant materials from and to various places as required.
3. To assist the Department's manual workers as and when required.
4. To be responsible for all tools and working materials taken in custody for works performance.
5. To perform other cognate duties.

4. Mode of Application
