

## **LOCAL GOVERNMENT SERVICE COMMISSION CIRCULAR NOTE NO 31 OF 2018**

### **VACANCY FOR THE POST OF VULCANISER MUNICIPAL TOWN COUNCIL OF CUREPIPE**

Applications are invited from among serving employees of the Municipal Town Council of Curepipe who wish to be considered for appointment as Vulcaniser in the Municipal Town Council of Curepipe.

The permanent and pensionable post carries salary in the scale of Rs 13010 x 260 – 14050 x 275 – 15150 x 300 – 15750 x 325 – 17700 x 375 – 19575 x 475 – 21950 x 625 – 23200 x 775 – 23975 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 13010 a month.

#### **II. QUALIFICATIONS:**

By selection from employees on the Permanent and Pensionable Establishment of the Municipal Town Council of Curepipe reckoning at least 10 years proven experience in the trade.

#### **NOTE**

- 1. In the absence of candidates as above consideration will also be given to employees on the Permanent and Pensionable Establishment who possess the Certificate of Primary Education and have at least 5 years proven experience in the trade.**
- 2. The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities rests on the candidates.**
- 3. Candidates should enclose photocopies of their National Identity Card, academic/technical qualifications and where applicable, equivalence of qualification and relevant documentary evidence of experience claimed.**
- 4. Candidates may be outposted to any sub office of the Local Authority.**

#### **III. DUTIES:**

- To work under the supervision of the Officer in Charge of the garage for:
  - (i) removing, repairing, reconditioning and reassembling tyres and inner tubes of all municipal vehicles and equipment;

- (ii) keeping a proper daily record of all repairs undertaken;
  - (iii) making good use and keeping in good order all tools, equipment and accessories used in the trade;
  - (iv) washing and lubricating all municipal vehicles.
2. To perform any other duties assigned to him by the Officer in Charge of the garage and his Head of Department.

- (iii) Candidates should submit their applications in duplicate, the original should be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer, who will forward it to the Commission within a week after the closing date.
