VACANCY FOR THE POST OF WELDER LOCAL GOVERNMENT SERVICE

Applications are invited from qualified candidates who wish to be considered for appointment as Welder in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs 13010 x 260 – 14050 x 275 – 15150 x 300 – 15750 x 325 – 17700 x 375 – 19575 x 475 – 21950 x 625 – 23200 x 775 - 23975 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 13010 a month.

2. AGE LIMIT

Candidates should have reached their **18th** birthday and unless already in the Local Government Service/Public Service/Approved Service, should not have reached their **48th** birthday by the closing date for the submission of applications.

3. QUALIFICATIONS

Candidates should reckon at least two years' experience in Welding and hold:

(i) the Certificate of Primary Education; and

Either

(ii) the National Trade Certificate (Level 3) awarded by the Mauritius Institute of Training & Development (MITD) in Welding

Or

(iii) the trade test certificate in Welding

Or

An equivalent qualification to (i), (ii) & (iii) above acceptable to the Local Government Service Commission.

Note 1: Candidates should show proof of all experience claimed.

Note 2: The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities, rests on the candidates.

Note 3: Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications and, where applicable equivalence of qualifications and relevant documentary evidence of all experience claimed.

Note 4: Candidates may be required to submit a Character Certificate.

4. DUTIES :

1. To carry out the necessary measurements and calculations of the trade.
2. To use and keep in good condition the tools in general use in the trade.
3. To work from simple drawings or sketches.
4. To carry out in an efficient manner all forms of welding in all thickness of material.
5. To make sound welds in down-hand, oblique, vertical and up hand positions.
6. To do accurate outside and inside welds between plates and between angle irons.
7. To ensure good safety conditions while on duty.
8. Other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.

5. Mode of Application

Qualified candidates should submit their applications :

- (iii) Candidates already in the Local Government Service should submit their applications in duplicate, the original should be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer, who will forward it to the Commission within a week after the closing date.
- (iv) Candidates are advised to read carefully the 'NOTES AND INSTRUCTIONS TO CANDIDATES' before filling in the application form.
