Applications are invited from qualified candidates who wish to be considered for appointment as Planning and Development Assistant in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs  $14600 \times 275 - 15150 \times 300 - 15750 \times 325 - 17700 \times 375 - 19575 \times 475 - 21950 \times 625 - 23200 \times 775 - 31725$  a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 14600 a month.

## II. AGE LIMIT:

Candidates should have reached their <u>18<sup>th</sup></u> birthday and unless already in the Local Government Service/Public Service/Approved Service, should not have reached their <u>40<sup>th</sup></u> birthday by the closing date for the submission of applications.

### III. QUALIFICATIONS:

A. A Cambridge Higher School Certificate with passes at Principal Level in at least two subjects including Geometrical and Mechanical Drawing <u>or</u> Design and Technology (Communication) <u>or</u> Design and Technology obtained on one certificate

Or

Passes in at least two subjects including Geometrical and Mechanical Drawing <u>or</u> Design and Technology (Communication) <u>or</u> Design and Technology obtained on one certificate at the General Certificate of Education 'Advanced Level"

Or

An equivalent qualification acceptable to the Local Government Service Commission.

B. Candidates should be computer literate.

#### NOTE:

The onus for the submission of equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Tertiary Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of Equivalence Certificate, as appropriate, by the closing date.
- 2. Candidates should enclose photocopies of their National Identity Card, academic/technical qualifications and where applicable, equivalence of qualification and relevant documentary evidence of experience claimed.
