Applications are invited from serving Tradesman's Assistants of the Local Government Service who wish to be considered for appointment as Automobile Electrician in the Municipal Town Council of Quatre Bornes.

The permanent and pensionable post carries salary in the scale of Rs 13010 x 260 – 14050 x 275 – 15150 x 300 – 15750 x 325 – 17700 x 375 – 19575 x 475 – 21950 x 625 – 23200 x 775 – 23975 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 13010 a month.

II. QUALIFICATIONS

By selection from among Tradesman's Assistants in the Local Government Service possessing the trade test in Automobile Electric or hold a certificate in Automobile Electric from a recognized institution, acceptable to the Local Government Service Commission.

- Note 1: Candidates should show proof of all experience claimed.
- <u>Note 2</u>: The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities rests on the candidates.
- <u>Note 3</u>: Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications and where applicable, documentary evidence of all experience claimed.

III. DUTIES

- 1. To carry out the necessary measurements and calculations of the trade.
- 2. To use and keep in good condition the tools in general use in the trade.
- 3. To be conversant with all types of electric wiring in vehicles.
- 4. To localize electrical faults and effect the necessary repairs including adjustments and replacement of brushes and contacts in magnetos, dynamos and starters.

- 5. To repair and replace horns, flashers, major and minor lanterns, wipers etc.
- 6. To repair and replace batteries.
- 7. To ensure good safety conditions while on duty.
- 8. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.
