Applications are invited from among serving employees of the Municipal Town Council of Vacoas/Phoenix who wish to be considered for appointment as Chemical Sprayer Operator in that Municipal Town Council.

The permanent and pensionable post carries salary in the scale of Rs 14725 x 250 – 15225 x 260 – 17825 x 275 – 18925 x 300 – 19525 x 325 – 21475 x 375 – 22225 x 400 – 23425 x 525 - 23950 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 14,725 a month.

II. **QUALIFICATIONS**

By selection on the basis of experience and merit of employees having a minimum aptitude in the job.

III. <u>DUTIES</u>

- 1. To mix insecticides/herbicides used for the spraying of buildings, drains, riverbanks, etc.
- 2. To carry out the spraying.
- 3. To maintain and take proper care of the spraying apparatus.

- 4. To clean his sprayer and its accessories at the end of every working day.
- 5. To perform weeding work when not busy with the spraying apparatus.
- 6. To perform other cognate duties.
