# VACANCY FOR THE POST OF PLANT AND EQUIPMENT OPERATOR DISTRICT COUNCIL OF PAMPLEMOUSSES

Applications are invited from among serving employees of the District Council of Pamplemousses who wish to be considered for appointment as Plant and Equipment Operator in that District Council.

The permanent and pensionable post carries salary in the scale of Rs  $15485 \times 260 - 17825 \times 275 - 18925 \times 300 - 19525 \times 325 - 21475 \times 375 - 22225 \times 400 - 23425 \times 525 - 25000$ .

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 15,485 a month.

## 2. **OUALIFICATIONS**

By selection from employees on the Permanent and Pensionable Establishment of the District Council of Pamplemousses.

**Note:** The possession of the Certificate of Primary Education and/or proven experience in the operation of plant and equipment would be an advantage.

#### **NOTE:**

- 1: The onus for the submission of written evidence of experience claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience claimed and Equivalence Certificate, as appropriate, by the closing date.
- 2: Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications.
- 3: Candidates are informed that they may be outposted to any sub office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.

## 3. DUTIES

To be responsible for:-

1. operating manually or mechanically different types of machines or equipment viz Bitumen Sprayer, Concrete Mixer, Drilling Plant, Pneumatic Hammer and Stone Breaker/Broomwade;

- 2. carrying out routine maintenance and minor repairs or adjustments to the plant or equipment to ensure its safe working;
- 3. reporting any mechanical defects to the Chief Mechanic;
- 4. working the handwheel control for the tilting of mixing bowl;
- 5. washing the bowl after use;
- 6. helping to tow the concrete mixer to any vehicle pulling same;
- 7. helping generally in masonry work;
- 8. melting and proper spraying of coaltar;
- 9. breaking stones with pneumatic drills of air compressor;
- 10. operating air compressor;
- 11. any other cognate duties as may be assigned to him.
