Applications are invited from qualified candidates residing within the boundaries of the Municipal Town Council of Vacoas/Phoenix who wish to be considered for appointment as Tradesman's Assistant (Mason) in that Municipal Town Council.

The permanent and pensionable post carries salary in the scale of Rs 13975 x 250 – 15225 x 260 – 17825 x 275 – 18925 x 300 – 19525 x 325 – 21475 x 375 – 22225 x 400 - 22625 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 13,975 a month.

2. <u>AGE LIMIT</u>

Candidates should have reached their <u>18th</u> birthday and unless already in the Local Government Service/Public Service/ Approved Service, should not have reached their <u>48th</u> birthday by the closing date for the submission of applications.

3. **QUALIFICATIONS**

By selection from among candidates residing within the boundaries of the Municipal Town Council of Vacoas/Phoenix who possess:

- (a) the Certificate of Primary Education; and
- (b) the National Trade Certificate (Level 3) awarded by the Mauritius Institute of Training and Development (formerly Institute of Vocational Training Board) in masonry or an equivalent qualification from a recognised institution acceptable to the Local Government Service Commission.

NOTE:

- 1. Candidates should produce written evidence of experience claimed.
- 2. The onus for the submission of written evidence of experience claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience claimed and Equivalence Certificate, as appropriate, <u>by the closing date</u>.
- 3. Candidates should enclose photocopies of their National Identity Card and academic/professional qualifications and proof of residential address.

- 4. Candidates may be requested to submit a Certificate of Character.
- 5. Applicants are informed that they may be outposted to any Sub Office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.

4. <u>DUTIES</u>

- 1. To work under the supervision of the Tradesman and assist him in the performance of his duties.
- 2. To be familiar with the tools of the trade and to use them to perform operations as appropriate, under the guidance of the Tradesman, so as to develop gradually the skills necessary for the trade.
- 3. To ensure, under the Tradesman's guidance that all tools, equipment and accessories used in the trade are kept in good working order.
- 4. To carry out simple repair works and other operations as may be directed by the Tradesman.
- 5. To be able to read and work from dimensional plans, drawings and sketches.
- 6. To perform such other duties directly related to the main duties listed above or related to the delivery of output and results expected from incumbents in the roles ascribed to them according to their posting.
