The permanent and pensionable post carries salary in the scale of Rs. $23025 \times 400 - 23425 \times 525 - 26050 \times 675 - 27400 \times 825 - 35650 \times 900 - 37450 \times 950 - 42200 \times 1300 - 46100 \times 1575 - 49250$ a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs23025 a month.

2. AGE LIMIT

Candidates should have reached their **18**th birthday and unless already in the Local Government Service/Public Service/Approved Service should not have reached their **45**th birthday by the closing date for the submission of applications

3. **QUALIFICATIONS:**

By selection from candidates possessing:

(i). A Cambridge School Certificate with credit in five subjects including English Language, French and Mathematics or Principles of Accounts obtained at not more than two sittings

Passes not below Grade C in at least five subjects including English Language, French and Mathematics or Principles of Accounts obtained at not more than two sittings at the General Certificate of Education "Ordinary Level" provided that at one of the sittings, passes have been obtained either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject.

An equivalent qualification acceptable to the Local Government Service Commission

Note:

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at "Principal Level" and one subject at "Subsidiary Level" as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.
