Applications are invited from candidates residing within the boundaries of the District Council of Flacq who wish to be considered for appointment as Sanitary Attendant (Part Time) in that District Council.

The selected candidate will draw an allowance of Rs 5,675 a month.

2. AGE LIMIT

Candidates should have reached their <u>18th</u> birthday and unless already in the Local Government Service/Public Service/ Approved Service, should not have reached their <u>48th</u> birthday by the closing date for the submission of applications.

3. **QUALIFICATIONS**

By selection from candidates residing within the boundaries of the District Council of Flacq and possessing the Certificate of Primary Education.

Note: In the absence of candidates possessing the above qualification, consideration will be given to candidates who show proof of being literate.

Note:

- 1: The onus for the submission of written evidence of Knowledge/experience claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge/experience claimed and Equivalence Certificate, as appropriate, by the closing date.
- 2: Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications and proof of residential address.
- 3: Candidates may be required to submit a Certificate of Character.
- 4: Applicants are informed that they may be outposted to any sub office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.

4. **DUTIES**

- 1. To open and close toilets at the stipulated time.
- 2. To clean washbasins and lavatories accessories and flooring.
- 3. To be responsible for the thorough cleansing and disinfection of all public toilets as well as those within the Council's premises several times a day and as required.
- 4. To watch over such premises and to see that all sanitary fittings and apparatus are in good working condition and to report any defect or discrepancy.
- 5. To ensure that the surrounding areas are kept clean at all times and in proper hygienic condition for utilization.
- 6. To remove and clear obtrusive matters in discharge pipes, manhole and traps.
- 7. To be responsible for all materials and equipment under his/her control.
- 8. To perform such other duties directly related to the main duties listed above or related to the delivery of output and results expected from incumbents in the roles ascribed to them according to their postings.

5. MODE OF APPLICATION
