Applications are invited from qualified candidates residing within the boundaries of the Municipal Town Council of Vacoas/Phoenix who wish to be considered for appointment as Handy Worker (Sanitation/Disease Control) in that Council.

The permanent and pensionable post carries salary in the scale of Rs 13745 x 230 - 13975 x 250 - 15225 x 260 - 17825 x 275 - 18925 x 300 - 19525 x 325 - 21475 x 375 - 22225 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 13,745 a month.

### 2. <u>AGE LIMIT</u>

Candidates should have reached their <u>**18**</u><sup>th</sup> birthday and unless already in the Local Government Service/Public Service/ Approved Service, should not have reached their <u>**48**</u><sup>th</sup> birthday by the closing date for the submission of applications.

### 3. **QUALIFICATIONS**:

By selection from candidates residing within the boundaries of the Municipal Town Council of Vacoas/Phoenix.

### NOTE:

- 1. The onus for the submission of written evidence/knowlege claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience claimed and Equivalence Certificate, as appropriate, <u>by the closing date</u>.
- 2. Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications and proof of residential address.
- 3. Candidates may be required to submit a Certificate of Character.

4. Candidates are informed that they may be outposted to any sub office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.

- 2. To collect and stack all rubbish and weeds from rivers and drains for removal by the scavenging services.
- 3. To remove and bury all dead animals found in rivers and drains.
- 4. To perform any cognate duties.
