VACANCY FOR THE POST OF AUTOMOBILE ELECTRICIAN
LOCAL GOVERNMENT SERVICE

Applications are invited from qualified candidates who wish to be considered for appointment as Automobile Electrician in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs 15745 x 260 – 17825 x 275 -18925 x 300 – 19525 x 325 – 21475 x 375 – 22225 x 400 – 23425 x 525 – 26050 x 675 – 27400 x 825 – 28225 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 15745 a month.

II. AGE LIMIT:

Candidates should have reached their **18th** birthday and unless already in the Local Government Service/Public Service/Approved Service should not have reached their **48th** birthday by the closing date for the submission of applications.

III. QUALIFICATIONS:

By selection among candidates reckoning at least two years' experience in Automobile Electric and who hold:

- (i) the Certificate of Primary Education; and

Either

- (ii) the National Trade Certificate (Level 3) awarded by the Mauritius Institute of Training and Development (MITD) in Automobile Electric

Or

- (iii) the trade test certificate in Automobile Electric

Or

An equivalent qualification to (i), (ii) & (iii) above, acceptable to the Local Government Service Commission.

NOTE:

Candidates should show proof of all experience claimed.

Note:

- 1. The onus for the submission of written evidence of experience claimed and equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience claimed and Equivalence Certificate, as appropriate, by the closing date.*
- 2. Candidates should enclose photocopies of their National Identity Card and Academic/Technical qualifications.*
- 3. Candidates may be requested to submit a character certificate.*
- 4. Candidates are informed that they may be outposted to any Sub Office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.*

IV. DUTIES

1. To carry out the necessary measurements and calculations of the trade.
2. To use and keep in good condition the tools in general use in the trade.
3. To be conversant with all types of electric wiring in vehicles.
4. To localize electrical faults and effect the necessary repairs including adjustments and replacement of brushes and contacts in magnetos, dynamos and starters.
5. To repair and replace horns, flashers, major and minor lanterns, wipers etc.
6. To repair and replace batteries.
7. To ensure good safety conditions while on duty.
8. Other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.

V. MODE OF APPLICATION

- (i) Qualified candidates should submit their applications on **LGSC Form 7a** which may be obtained either from the Office of the Local Government Service Commission, Louis Pasteur Street, Forest Side or from any Local Authority.

- (ii) Candidates already in the Local Government Service should submit their applications in **duplicate**, the original should be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer who will forward it to the Commission within a week after the closing date.
