VACANCIES FOR THE POST OF CADASTRAL ASSISTANT IN THE LOCAL GOVERNMENT SERVICE

Applications are invited from qualified candidates who wish to be considered for appointment as Cadastral Assistant in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs $16785 \times 260 - 17825 \times 275 - 18925 \times 300 - 19525 \times 325 - 21475 \times 375 - 22225 \times 400 - 23425 \times 525 - 26050 \times 675 - 27400 \times 825 - 35650 \times 900 - 36550$ a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 16785 a month.

II. AGE LIMIT

Candidates should have reached their <u>18th</u> birthday and unless already in the Local Government Service/Public Service/Approved Service, should not have reached their <u>45th</u> birthday by the closing date for the submission of applications.

III. QUALIFICATIONS:

- 1. By selection from candidates possessing:
 - (a) Cambridge School Certificate with credit in at least five subjects including English Language, French Language and Mathematics or Principles of Accounts obtained at not more than two sittings

or

(b) Passes not below Grade C in at least five subjects including English Language, French and Mathematics or Principles of Accounts obtained at not more than two sittings at the General Certificate of Education "Ordinary Level" provided that at one of the sittings, passes have been obtained either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject

<u>or</u>

(c) an equivalent qualification acceptable to the Local Government Service Commission.

NOTE 1:

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at "Principal Level" and one subject at "Subsidiary Level" as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

2. A Cambridge Higher School Certificate <u>or</u> Passes in at least two subjects obtained on one certificate at the General Certificate of Education "Advanced Level" <u>or</u> an equivalent qualification acceptable to the Local Government Service Commission.

NOTE 2:

Knowledge of AutoCAD Systems is desirable.

NOTE:

- 1. The onus for the submission of written evidence of experience/knowledge claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience/knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 2. Candidates should enclose photocopies of their National Identity Card and academic/technical/professional qualifications.
- 3. Candidates may be requested to submit a character certificate.
- 4. Candidates are informed that they may be outposted to any Sub Office of a Local Authority, and also, with the approval of the appropriate authority, to any Local Authority where their services will be required.

IV. DUTIES:

- 1. To be responsible to the Head, Land Use and Planning Department through the Cadastral Officer for: -
 - (i) preparing and updating all records including cadastre files, cards, registers, ledger sheets, etc;
 - (ii) dealing with the routine clerical and secretarial work in the Cadastre Section;
 - (iii) liaising with the Government Valuation Department;
 - (iv) carrying out surveys, as and when required, with a view to verify the accuracy of cadastre documents;
 - (v) ensuring that all immovable properties are duly assessed;
 - (vi) carrying out searches in connection with the transfer of properties at the office of the Registrar-General;
 - (vii) liaising with the Head of Income regarding outstanding matters related to unknown properties, double assessment, returned claims, etc;
 - (viii) providing assistance generally to the Cadastral Officer; and
 - (ix) registration, classification and processing of applications for Building and Land Use Permit for excision/subdivision of land/properties.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Cadastral Assistants in the roles ascribed to them according to their posting.

V. MODE OF APPLICATION:

(i) Qualified candidates should submit their applications on <u>LGSC Form</u> <u>7a</u> which may be obtained from the office of the Local Government Service Commission, Louis Pasteur Street, Forest Side <u>and</u> from any Local Authority.
