**VACANCY FOR THE POST OF TECHNICIAN (SOUND)
IN THE MUNICIPAL TOWN COUNCIL OF BEAU-BASSIN/ROSE-HILL**

Applications are invited from qualified candidates who wish to be considered for appointment as Technician (Sound) in the Municipal Town Council of Beau-Bassin/Rose-Hill.

The permanent and pensionable post carries salary in the scale of Rs 18100 x 275 – 18925 x 300 – 19525 x 325 – 21475 x 375 – 22225 x 400 – 23425 x 525 – 26050 x 675 – 27400 x 825 – 35650 x 900 – 37450 x 950 – 39350 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 18100 a month.

II. AGE LIMIT:

Candidates should have reached their **18th** birthday and unless already in the Local Government Service/Public Service/Approved Service, should not have reached their **45th** birthday by the closing date for the submission of applications.

III. QUALIFICATIONS:

By selection from candidates possessing:

- A. (i) A Cambridge School Certificate with credit in at least five subjects including English Language, French and Mathematics or Physics obtained at not more than two sittings

Or

- (ii) Passes not below Grade C in at least five subjects including English Language, French and Mathematics or Physics obtained at not more than two sittings at the General Certificate of Education "Ordinary Level" provided that at one of the sittings, passes have been obtained either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject.
- (iii) an equivalent qualification acceptable to the Local Government Service Commission

NOTE 1:

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at "Principal Level" and one subject at "Subsidiary Level" as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

- B. The Technician Diploma in Electrical and Electronic Engineering (including component 8030-112 Electronics)

Or

The Technician Diploma in Telecommunication Engineering 272 awarded by the City and Guilds of London Institute

Or

equivalent qualifications acceptable to the Local Government Service Commission.

- C. Proven experience in electronics and electricity.

NOTE 2:

Candidates should show written proof of experience claimed at paragraph C above.

NOTE

1. *The onus for the submission of written evidence of experience/knowledge claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience/knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.*
2. *Candidates should enclose photocopies of their National Identity Card and academic/technical/professional qualifications.*
3. *Candidates may be requested to submit a character certificate.*
4. *Candidates are informed that they may be outposted to any Local Authority or any Sub Office of a Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.*

IV. DUTIES:

1. To be responsible to the Sound and Lighting Designer for the:
 - (a) operation and maintenance of all items of sound equipment and fittings of the Municipal Theatre;
 - (b) setting of and repairs of sound equipment;
 - (c) execution of sound plots;
 - (d) record of attendance during performances and rehearsals;
 - (e) keeping proper records of all sound equipment of the theatre;
2. To advise the Sound and Lighting Designer on the purchase of new equipment and renewal of existing sound equipment and accessories.
3. To ascertain that work are carried out as planned and in compliance with relevant norms and standard.
4. Must be conversant with Departmental Orders for the prevention of accidents and have a fair knowledge of fire precautions.
5. To provide First Aid treatment in case of electric shock.
6. To work in close collaboration with the Stage Designer, Producers, Stage Managers and other Personnel involved in the preparation of shows.
7. To perform any other cognate duties as may be assigned.

NOTE:

The Technician (Sound) may be required to work at staggered and irregular hours including Sundays and Public Holidays, without payment of extra remuneration.

V. MODE OF APPLICATION

- (i) Qualified candidates should submit their applications on **LGSC Form 7a** which may be obtained from the office of the Local Government Service Commission, Louis Pasteur Street, Forest Side and from any Local Authority.
