**VACANCIES FOR THE POST OF WELDER IN THE LOCAL GOVERNMENT SERVICE**

Applications are invited from qualified candidates who wish to be considered for appointment as Welder in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs 24545 x 300 - 26945 x 320 - 28865 x 350 - 30965 x 400 - 31765 x 425 - 33040 x 560 - 35840 x 725 - 37290 x 925 - 38215 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 24545 a month.

**2. AGE LIMIT**

Candidates should have reached their **18<sup>th</sup>** birthday and, unless already in the Local Government Service/Public Service/Approved Service, should not have reached their **48<sup>th</sup>** birthday by the closing date for the submission of applications.

**3. QUALIFICATIONS**

Candidates should reckon at least two years' experience in Welding and who hold:

(i) the Certificate of Primary Education; and

**Either**

(ii) the National Trade Certificate (Level 3) awarded by the Mauritius Institute of Training & Development (MITD) in Welding

**Or**

(iii) the trade test certificate in Welding

**Or**

An equivalent qualification to (i), (ii) & (iii) above acceptable to the Local Government Service Commission.

**NOTE: Candidates should show proof of all experience claimed.**

**NOTE:**

1. *The onus for the submission of written evidence of knowledge/experience claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge/experience claimed and Equivalence Certificate, as appropriate, by the closing date.*
- 2 *Candidates should enclose photocopies of their National Identity Card and academic/professional/technical qualifications.*
- 3 *Candidates may be requested to submit a Character Certificate.*
- 4 *Candidates are informed that they may be outposted to any Sub Office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.*

**4. DUTIES :**

1. To carry out the necessary measurements and calculations of the trade.
2. To use and keep in good condition the tools in general use in the trade.
3. To work from simple drawings or sketches.
4. To carry out in an efficient manner all forms of welding in all thickness of material.
5. To make sound welds in down-hand, oblique, vertical and up hand positions.
6. To do accurate outside and inside welds between plates and between angle irons.
7. To ensure good safety conditions while on duty.
8. Other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.

**5. MODE OF APPLICATION**

- (i) Qualified candidates should submit their applications on **LGSC Form 7a** which may be obtained either from the Office of the Local Government Service Commission, Louis Pasteur Street, Forest Side or from any Local Authority.

- (ii) Candidates already in the Local Government Service should submit their applications in **duplicate**, the original should be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer, who will forward it to the Commission within a week after the closing date.
